 - (not a hospital certificate), or a valid passport.
- ✓ **Completed immunization documentation SIGNED BY MEDICAL AUTHORITIES.**
- ✓ **Completed [Registration Forms](#)**

Once the paperwork is completed call your local school (list below) to schedule an appointment so that we may finish the registration process, please.

Documentation of Residency

All parents/guardians must provide copies of current documents as proof of residency in the Township of Parsippany-Troy Hills. Documents are required to clearly indicate the names and addresses provided for the registration of all students. **Individuals must provide one (1) document from Category A and two (2) documents from Category B. (If possible, please bring copies not originals)**

<p><u>For Guardians Only</u></p> <p>Guardians must provide proof of legal guardianship by providing a copy of Court orders, State agency agreements, or other evidence of court or agency placements or directives.</p> <p>OR</p> <p>Affidavits, certifications and sworn attestations pertaining to statutory criteria for school attendance, from the parent, legal guardian, person keeping an "affidavit student," person(s) with whom a family is living, or others as appropriate.</p>		

The totality of information and documentation received will be considered in evaluating an application, and, unless expressly required by law, the student will not be denied enrollment based on the lack of any specific form (an exception to this rule would be the Court Order or Affidavit Pupil situation).

If you are unable to complete your registration due to a residency issue please see procedures for Non-Resident Enrollment below.

Procedures for Enrollment

If you were unable to complete your registration due to a residency issue please do the following:

- **Call Mrs. Joni Benos @ (973) 263-7200 ext. 7250 and schedule an appointment.**
- The ParsIPPANY resident that you are living with needs to be available to go with you to the appointment with Mrs. Benos.
- At the meeting the materials needed will be:

PARSIPPANY RESIDENT

- Personal identification (Driver's License or Passport)
- A copy of your lease, deed, or current tax bill.
- 2 current bills
- If you live in an apartment you must provide a letter from the Manager stating that they are aware of who is living with you in the apartment.

NON-RESIDENT LIVING WITH PARSIPPANY RESIDENT

- Personal identification (Driver's License or Passport)
- If you have established your residence at this address and have proof of that residency such as a: tax bill, current utility bill, automobile registration, health insurance etc. bring that with you as well.
- You will be given thirty days from the date of your appointment with Mrs. Benos to establish your residency if you have not done so.

NON-RESIDENT LIVING IN RELATIVE'S RESIDENCE

- Owner needs to complete Statement of Residency Verification and have Notarized
- If owner lives out of town they need to submit notarized form along with letter that they have granted permission for registrant to reside in their home
- Owner needs to show proof that home is under their name
